Article four: Reports.

Point one: Don Harry reports on the repair of the police car.

Point two: Scott informs that \$ 100,000 must be raised to start the study of the sewage treatment. Support will be asked to banks, breweries and suppliers who have more incomes, as well as some hotels. He proposes to make a list of the largest hotels in the area, and present it at the next meeting.

Point three: Fanny informs that she wants to revive the Festival Del Mar, and her plan is to close the streets so domestic traders in the area can sell their merchandise. She also comments that the Municipality has a plan as well, but she is not aware of it, and she want to set up the project to benefit the community. Don Richard motions that if the council has a plan, we must let them develop it.

Point four: Richard informs on the inclusion of Mr. John Oroszi to be Xinia's new assistant, and help implement the plans of the Manuel Antonio National Park Board. Don Richard proposes that John contacts Alex Baker to see if it can revive the newspaper El Costanero, or whether if he is willing to sell it.
